- c Sections 191.724 and 376.1199 were contained in SB 749, which was vetoed by the Governor on July 12, 2012. The General Assembly voted to override the veto on September 12, 2012. Pursuant to Sections 1.130 and 21.250, Section 191.724 became effective September 12, 2012, and Section 376.1199 became effective October 12, 2012.
- d Section 301.140 was contained in four bills. SB 470 (Section C), SB 568 (Section D), and SB 611 (Section B) contained an effective date the earlier of July 1, 2013 or a contingency, which language was codified as subsection 11 of Section 301.140. HB 1402 did not contain the contingent effective date. Due to this delayed contingent effective date, two versions of this section are printed until either the effective date is reached or the contingency is met.
